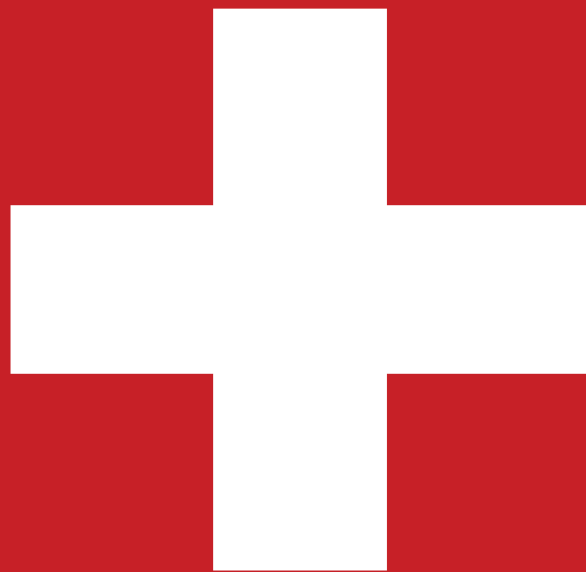


# 15-jarige CO2- emissiehandelcertificaten kant-en-klare Zwitserse AG

## 15-jarige CO2-emissiehandelcertificaten kant-en-klare Zwitserse AG

Deze besloten vennootschap met beperkte aansprakelijkheid, met statutaire zetel in Sarnen, Zwitserland, werd opgericht in december 2011.

De belangrijkste doelstelling van het bedrijf is het leveren van advies- en managementdiensten, naast de handel in CO2-emissiecertificaten. Eventuele aanvullende of bijkomende doeleinden worden beschreven in de statuten van het bedrijf.

Het aandelenkapitaal van de onderneming bedraagt CHF 20.000,00, verdeeld in 20 aandelen van CHF 1.000,00 elk.

Het bedrijf heeft een lopende rekening bij het Federaal Milieuagentschap in Zwitserland.

Zwitserland heeft een sterk gedecentraliseerd belastingstelsel, met belastingen op drie niveaus: federaal, kantonnaal en gemeentelijk. Dit betekent dat de totale belastingdruk aanzienlijk kan variëren afhankelijk van het kanton en zelfs de specifieke gemeente (commune) binnen dat kanton.

Sarnen is de hoofdstad van het kanton Obwalden, dat bekend staat om zijn aantrekkelijke belastingklimaat en vaak tot de kantons met de laagste belastingtarieven van Zwitserland behoort.

Hier volgt een overzicht van de belastingen in Sarnen/Obwalden:

### 1. Federale belasting (directe federale belasting):

- **Inkomstenbelasting (Particulieren):** De federale inkomstenbelasting is progressief, met een maximaal totaal tarief van 11,5%. Voor gehuwde belastingbetalers wordt het belastingtarief toegepast op 50% van hun gezamenlijke inkomen (bekend als "splitsen").
- **Vennootschapsbelasting:** De directe federale vennootschapsbelasting is 8,5% op de nettowinst. Door de aftrekbaarheid van inkomsten- en vermogensbelasting is het effectieve federale vennootschapsbelastingtarief ongeveer 7,83%.
