Voor overname is een portfolio van zes iOS-apps beschikbaar die mobiel printen, faxen, scannen, gespreksopname en VPN-diensten bieden. De hoofdapp biedt mobiel afdrukken en is een van de oudste apps in deze niche. Het is wereldwijd al meer dan 4 miljoen keer geïnstalleerd. Ongeveer 70% van de huidige abonnees is al meer dan een jaar geabonneerd (12 periodes) en hun bounce rate en churn is veel lager dan bij nieuwe abonnees. Deze kern draagt het grootste deel van de winst en zal dat ook blijven doen, ongeacht de omstandigheden.

Categorie voor deze app is Business & Office tools. Het is geschikt voor een paar niches – afdruk-apps, scanner-apps, apps voor het beheren en bewerken van documenten. Het biedt geavanceerde afdrukopties die niet zonder app kunnen worden gebruikt. De niche is duurzaam, met regelmatig verkeer en interesse. Groeimogelijkheden zijn onder andere meer verkeer via ASA, ASO en betaalde kanalen (die nog nauwelijks zijn getest).

Om het verkeer en de inkomsten te verhogen, beschikt de nieuwe eigenaar idealiter over een toegewijd team van specialisten die zich op dit bedrijf richten en klaar zijn voor marketingactiviteiten – werken met ASA, ASO, betaalde kanalen, testen en het verhogen van de conversie. Het huidige team kan niet veel tijd besteden aan deze processen.
