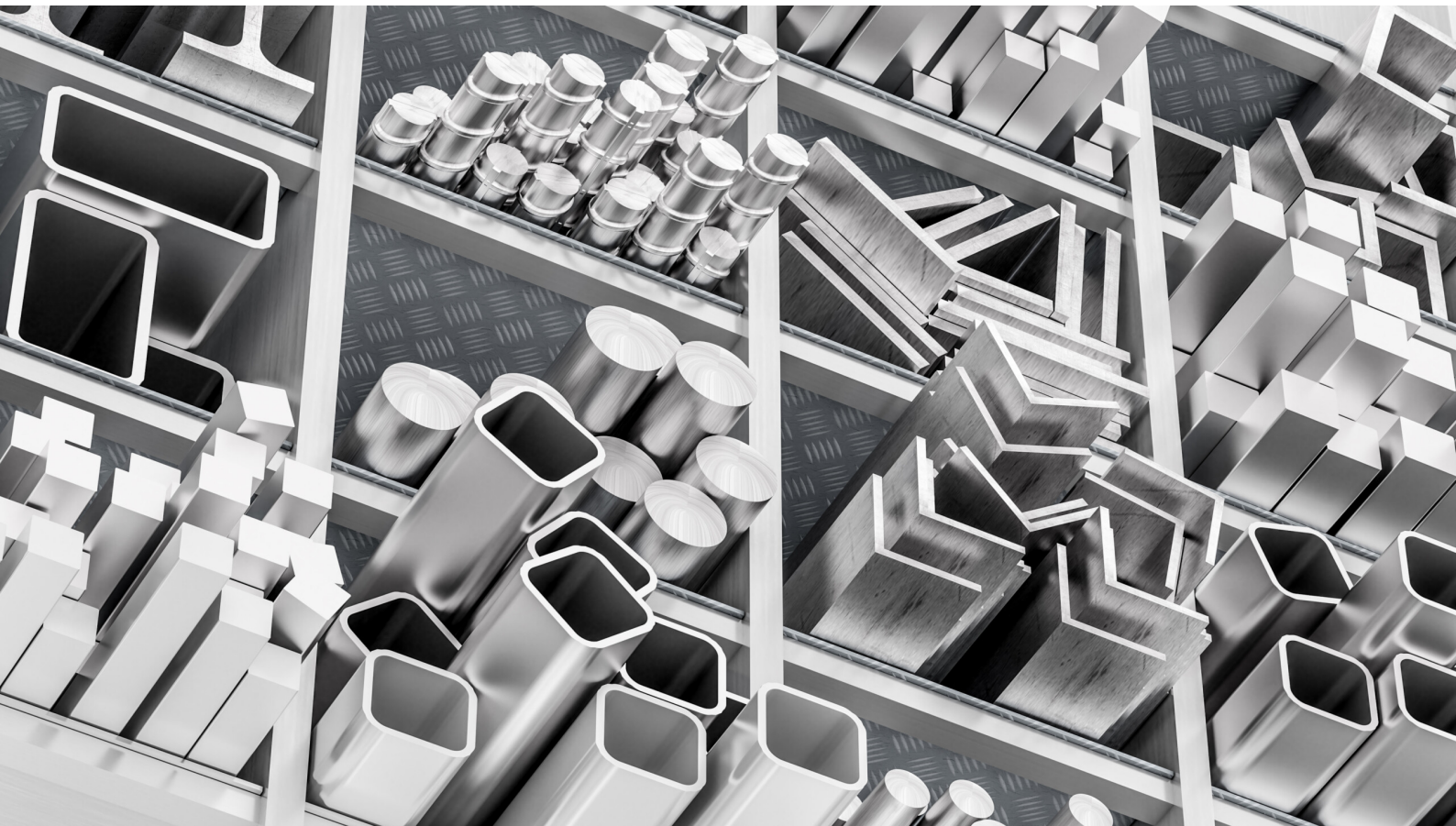

Opgericht in 1991, deze productie metaal bedrijf te koop is een van de toonaangevende Aluminium profiel producent in Turkije. Het metaalbedrijf landde op een totale oppervlakte van meer dan 40.000 m² in de buurt van Istanbul. Het bedrijf heeft 3 extrusielijnen met schalen van 2750, 1850 en 1540 ton. De 2750 extrusiepers van het bedrijf is een van de grootste automatische persen in de industrie, die 310 mm brede en 13,4 meter lange getemperde profielen kan produceren.

Met een productiecapaciteit van meer dan 20.000 ton per jaar houdt het bedrijf zich bezig met de productie van standaardprofielen, sigmaprofielen, meubelprofielen, led-/koelprofielen en zonne-energieprofielen.

Concurrentievoordelen

Het bedrijf heeft een sterke risicobeperkingsstrategie door zijn klantenbasis te diversifiëren, het verkoopt via industriële bedrijven en bouwbedrijven in heel Turkije (meer dan 20 landen en meer dan 300 klanten in het buitenland).

Kansen

Het verbruik van primair aluminium is tussen 2013 en 2017 wereldwijd met 21,3% gestegen, wat de dynamiek van de downstreammarkt en de hogere penetratie van het metaal weerspiegelt. De wereldwijde groei van de vraag naar aluminium zal tot 2021 naar verwachting 3,8% bedragen.

In 2019 bedroeg de omvang van de wereldwijde aluminiummarkt 123,2 miljard USD. De productgroep Staven, Bladen en Rollen was goed voor 26,7% van de wereldwijde aluminiummarkt.
