- **Academy van topklasse:** De organisatie heeft een eersteklas jeugdsector die consequent talent van professionele kwaliteit voortbrengt. Deze "productielijn" zorgt voor een terugkerende inkomstenstroom door de verkoop van spelers en verlaagt de kosten voor het samenstellen van het eerste elftal.
- **Dominante marktpositie:** Als belangrijkste sportentiteit in de provincie heeft de club een trouwe, "monopolistische" schare fans met gemiddelde bezoekersaantallen die vaak hoger liggen dan die van verschillende topclubs (eerste divisie).
