Kirgizië heeft veel van de grootste goudmijnen in Centraal-Azië.

Gelegen op de noordelijke hellingen van de Kirghiz Range, in de bovenloop, rechtercomponenten van de Karabulak stroom, in het centrale deel van de Bulakashinsky ertsvelden.

Vulkanisch gesteente speelt een rol in de geologische structuur van de site. gesteenten vertegenwoordigd door andesieten en andesiet-basalten, hun tufstenen en clastolava's. Intrusieve gesteenten worden vertegenwoordigd door gabbro-shonkinieten, syeniet-diorieten en granodiorieten, die afzonderlijke fasen zijn van één intrusief complex. Een karakteristiek kenmerk van de formaties van dit complex is hun plaatvormige, zacht glooiende voorkomen met diphoecken van 10 o tot 50 o , in de omringende vulkanisch-sedimentaire gesteenten.

Met deze structuren en geassocieerd met de vorming van gemineraliseerde zones en ertslichamen van de afzetting.

Geïdentificeerde goud- en kopermineralen, evenals zones van beresitatie en silicificatie op de Severny-locatie, zijn ofwel direct beperkt tot granodiorietintrusies, of, vaker nog, hun intrusieve contacten met vulkanogene en intrusieve gastgesteenten.

De zonebreedte beresitatie bereikt hier de eerste tientallen meters. getraceerde lengte tot 400 m. Onder de beresieten is de meest intense ader silicificatie, met verspreide verspreiding van sulfiden van koper, lood, ijzer, molybdeen.

Kernpunten

De goudafzetting is eigenlijk één groot veld dat bestaat uit meerdere goudafzettingen en 1 koperafzetting. De verkoper beweert dat hij een hoge goudkwaliteit heeft (goudpercentage per 1 ton). Het veld is echter niet goed ontwikkeld. Alle gegevens zijn verzameld door Sovjet-ingenieurs en het lijkt erop dat er sinds die periode niets meer is gedaan.

De reserves die volgens Canadese of Australische normen als P1 en P2 zijn gekwalificeerd, zijn gelijk aan: Exploratieresultaten, Exploratiedoelen, Exploratiepotentieel of zelfs een aantal als Uitgesteld. Dit is het laagste niveau van exploratie
